EAA Meeting 11-09-2005

I: Call to Order: Meeting called to order by President Alan Sickenger at 7:08 PM in the Aircraft Sales hangar at PHD.

II: Secretary's Report: Read by Secretary Aaron Davis. One correction was made and the motion to accept the Secretary's report with correction was passed with a motion by Ken Prater with a second by Randy Maley.

III: Treasurer's Report: Read by Treasurer Frank Price. Balance as of October 12: \$7,442.87 with four checks outstanding. Current balance: \$7,170.79. Three bills were presented.

- A. Two bills were for postage
- B. Another bill for postage for the Udvar-Hazy postcards

Motions: 1. Pay the bills: Motion by Don Knisely with a second by Ken Prater. Motion passed.

- 2. Accept Treasurer's report as read: Moved by Art Sickenger with a second by Don Knisely. Motion passed.

IV: Old Business:

- 1. Glasair inventory sheet: Inventory sheet received from Glasair. We are missing about 30% to 40% of the parts. The sheet is almost completed and should be sent back to the company by 11-14-2005.
- 2. Christmas Party : To be held on 12-10-2005 at the Perfect Landing restaurant. Members are asked to be there at 6:00 PM and we will eat at 6:30 PM. The meal is \$11.95 each (tip not included) and there is an extra cost for alcohol which is to be paid by the person ordering the alcoholic beverage. Frank made a motion to accept the terms for the Christmas party with a second by Randy. Motion passed.

V: New Business:
